Mayor Makes 'Deal Of Decade' for Land In City Center for About \$62k an Acre

**CENTRAL** — The City of Central has purchased 9.55 acres of land near the intersection of Hooper and

near the intersection of Hooper and Sullivan roads for construction of a new City Hall. The property is located on the west side of Hooper. Mayor David Barrow negotiated the deal with Jay and Ray Devall, whose family has owned the land for generations. The purchase price of \$594,000, or \$62,198 an acre, is low for the City Center. After debating the future of City

After debating the future of City Hall over the past several years, the City Council voted 6-1 to approve the land purchase, with Councilman Dave Freneaux voting no.

Barrow said he and the City Council will work with the architect to develop plans for the new City Hall. He hopes that the prop-erty will eventually include a City Hall Annex for Central City Services and perhaps the Police Department.

# Devall Family Is Happy at New Use of Property 9.55 Acres for Central City Hall

"There are many other possibilities which have been discussed including a Drivers License office, Tax Assessor's office, and a branch of the Clerk of Court's office," he said. "The back of the property is beautiful. I would like us to preserve that area for community events, perhaps with a pavilion where people could gather and bands could play." Although the price for the prop-

Although the price for the property was modest on a per-acre basis, Jay Devall said he thought it was fair. "Mainly, we just want the property to serve the community we love so much! We are excited about our homeplace being where City Hall is located!" he said.

His twin brother Ray said at age

75 they wanted to settle their affairs rather than dragging out the sale waiting for the best price.


Jay says Ray is the older of the two. "He's got me beat by 23 minutes!" Jay said. Growing up on Sullivan Road in Central was a great place to be in the 1950's and 1960's. They were related to almost everyone and friends with the rest.

They played football and basketball, and ran track at Central High. On offense, they played end— at opposite ends of the line — and on defense they both played linebacker. In 1964, their team was state runnerup under Coach Misita. Jay and Ray went on to play college football at Southeastern but both suffered injuries early on. They lost their brother Randy who died

in his 30's.

The twins inherited the property from their parents, Virgil and Melba Devall. Melba's father, Julius Robinson, gave Virgil and Melba one acre of the land and they purchased the rest from him. Mr. Robinson owned the Kaiser automobile dealership on the northeast corner of Hooper and Sullivan in the 1940's. Kaiser produced 750,000 automobiles from 1945 to 1955. It later merged with AMC. Today a successor company produces Humvees. The old Kaiser building is still there on the corner. It houses a number of small businesses.

The 9.55-acre tract has been used as a homesite for the Devall See HISTORY on Page 4





family and most recently for Laura's Jewelry and Capalli's Salon. Starting in the 1970's, the buildings were used for Burger Chalet owned by Virgil Devall and Rep. Donald Ray Kennard and for a washateria.

Virgil Devall served as Constable for 42 years. For much of that period, his Justice of the Peace was Sterling Kennard, father of Donald Ray. For decades, Virgil Devall, Sterling Kennard, and East Baton Rouge Parish School Board member T. H. Montgomery were the only elected officials in Central. All were among the longest-serving public officials in Louisiana.

At one point, Virgil and Melba Devall owned part of the land with J. A. Smith, the legendary principal at Central High from 1938 to 1968 and principal at Central Private from 1968 to 1978.

Virgil Devall and his three brothers — Gene, Julius, and Melvin — all served in World War II. Virgil



was a long-time member of Zoar Baptist and the Masonic Lodge. Melba also served as a school bus driver.

Jay Devall was elected and served on the East Baton Rouge

Parish School Board for 12 years. As Central worked to form its on

independent school district in 2005-2006, Jay stayed on the East Baton Rouge Parish School Board to make sure students on the north

After Central formed its own school district, Jay continued on the School Board for about a year to make sure Central got a fair deal in the transition. The ownership of land, buildings, mineral leases, buses, computers, and many other things were at issue during the transition. When that process was complete, Jay resigned from the East Baton Rouge School Board.

After studying industrial technology at Southeastern, Ray worked at Dow Chemical and taught at Baker and then Central. He retired from Exxon in 2003 and then worked 10 more years as a welding inspector. Jay worked for Delta Southern and then Lafayette Logistics. Afterwards, he went to Exxon, where he retired.

Jay's wife Rubye and Ray's wife Ruth were also involved in the sale and the decision making.

Rubye said how much she has enjoyed being part of the Devall family. "One of the most wonderful things was having Virgil and Melba Devall as my father- and mother-inlaw. No one could possibly want any better than the relationship we had."

Jay told a funny story about his mother and father. "We had the washeteria where Laura's is now, but my dad decided he needed to close the washeteria because it couldn't seem to make any money. Little did he know that that's where my mom got her grocery money! And I think Rubye was helping her!" Rubye laughed and chimed in, "I'm pretty sure he knew what was going on!"

Jay and Rubye still own their house in Central but spend most of their time at their place on the Tangipahoa River near Ponchatoula. Rubye loves animals and has goats, chickens, four cows, and guardian dogs for the goats.

The sale of the land for City Hall was handled by a local realtor, Michelle Jones, who happens to be Ray's stepdaughter-in-law. Mayor Barrow said it was fun to work with her, because she loves the property too.

Ray summed up his feelings and those of his brother, saying, "We're just happy to have the family property working for the community we love, and if City Hall ends up being here, that would be a wonderful thing for us!"







Act, which applies to cities that are not under a home rule charter. The city has an elected mayor and an elected police chief. The city council consists of seven members. Five are elected from single-member districts and two are elected at-large. The City of Central is unique in a number of ways. It is the only completely privatized city in Louisiana and one of the few in the U.S. All city services are provided by a private contractor. The city runs strong surpluses and has tens of millions in reserve. It is overwhelmingly Republican and conservative.

# **Central School Board to Be Elected Nov. 8**



The Central Community School District was created as a result of an amendment to the Louisiana Constitution approved by voters statewide, in East Baton Rouge Parish, and in Central in 2006. The interim school board was appointed by Gov. Kathlene Blanco in January 2007. They selected Mike Faulk as district superintendent. The first employee hired was Coach Sid Edwards. The new board officially took over the existing schools in the district on July 1, 2007, and schools in Central opened in August 2007. Voters in the district chose the first elected board that fall. Today, the Central Community School System is one of the highest performing in Louisiana. It operates five schools. The district superintendent is Dr. Jason Fountain.

# Door Open for Transgender Substitute Teachers If Central Schools Contract with Kelly Services

open for transgender substitute teachers in Central schools if a proposed contract with Kelly Services is approved by the Central School Board. The school system has had problems attracting substi-tute teachers this year.

Over the objections of Central School Board member Kim Pow-ers, the Central School Board is moving forward with a plan that would make this "Woke" interna-tional company the primary sup-plier of substitute teachers for the school system.

Kelly Services, which has made an international pledge of no discrimination based on "sexual orientation or gender identity/ expression," would be providing substitute teachers for the school system. Administrators said principals could still reject the substitute teachers provided by Kelly but exactly how that rejection would oc-cur was unclear. Normally, most substitute teachers simply sign in at the beginning of the school day. Kelly has made the pledge not to discriminate on "sexual orientation or gender identity/expression" in "assignments."

The Central School Board's Fi-

**CENTRAL** — The door could be nance Committee recommended moving forward with the plan at a committee meeting Monday night. School Board member David Walker said the school system should partner with Kelly Services for the rest of the school year to see how it works out. The proposed contract will go to the full board at its next meeting. A majority of the board serves on the Finance Committee.

School board member Kim Powers said substitute teachers should be chosen primarily from among Central residents, not an outside firm and certainly not by a "Woke"

international firm like Kelly. "They are flat out telling us they will not discriminate based on 'sexual orientation or gender iden-tity/expression.' That's really all I need to know!"

Powers said Central residents desiring to substitute teach should be paid enough to make it attractive. "Most substitute teachers in Central are being paid less than \$8 an hour. It makes no sense to pay starting teachers \$50,000 a year and then wonder why you can't find substitute teachers for under \$8 an hour," she said. "If McDonald can't find employees for \$8 an

hour, how can we expect to find substitute teachers at that salary?" she said."

You can bet Kelly will be paying a lot more than \$8 an hour, and we taxpayers will pay a lot more but through a middle man. We will probably end up paying Kelly \$25 to \$30 an hour. Why not simply increase pay for substitute teach-ers and hire them directly as we always have?" she asked.

Powers said after the meeting that hiring people with confused sexual identity would be an obvi-ous and grievous mistake. "The people of Central want nothing to do with the Woke culture, and I can't believe this contract is even being considered," Powers said.

Powers, who is new to the board after having been elected in a special election last year, said she was shocked to learn that no other company besides Kelly has even been considered by the school system.

Kelly Services operates in many countries including China, India, virtually all of Europe, the U.S., Canada and Mexico. It's website says Kelly aligns with the UN Guiding Principles on Business and Human Rights and is a signatory of the United Nations Global



In August, the U.S. Depart-ment of Education said Central must allow transgender students full access to bathrooms and other facilities of its choice in order to continue receiving federal lunch funds. State Supt. of Education Cade Brumley said he opposes this federal mandate and is willing to fight it.





# City of Central Budget The \$64 Million Dollar Question

It has been reported that the city has a \$64 million surplus and it's not being spent. This is not true! The majority of these funds are dedicated and restricted:

As of June 30, 2022, the city's fund balance was nearly \$60.2 million. Of that amount, only \$13.9 million was unrestricted and available for general use. The remainder was restricted to dedicated funds, projects, and uses.

- General Fund: \$20.2 million, of which \$6.3 is restricted for the Operating Reserve Fund.
- Emergency, Drainage, Road Fund: \$13.8 million restricted for these purposes only. (\$9.4 million for emergencies, \$3.6 million for drainage, and \$800,000 for roads).
- Half-Cent Sales Tax Fund: \$11.1 million for new construction, rehab, and sidewalks: 1) \$9.4 million for new road construction, of which the Mayor has \$15 million in proposed projects. 2) \$1.2 million for street rehab/overlays. 3) \$460k for sidewalks and beautification.
- MovEBR Fund: \$2 million dedicated for road construction, signal synchronizations, and upgrades, and sidewalk projects.
- Traffic Impact Contributions: \$241k in funds received from developers for traffic impacts.
- Capital Outlay: \$12.8 million for construction-related projects, of which \$5.2 million is restricted and \$7.6 million is committed funds for major roadway and drainage projects.





# Four Competing for District Judge Nov. 8

Can Republicans Re-Take Judgeship In Northern District Of East BR Parish?

**CENTRAL** — Central's Judge Richard Anderson served as a District Judge for many years in the 19th Judicial District. He was respected by judges, lawyers, and the general public. His decisions were uniformly upheld, and he had no scandals of any kind.

Yet, on Nov. 3, 2020, Judge An-derson was defeated by a young Democratic attorney. The reason? In East Baton Rouge Parish, voters elect five judges from each of three judicial sub-districts, and these sub-districts have not been reappor-tioned in 30 years. They are badly malapportioned, and black voters are highly overrepresented.

The so-called minority subdistrict has a voting population of 57,325 and elects five District Judges. The Northern sub-district. which includes Central and Zachary, has 100,093 voters and elects only five District Judges. And the Southern sub-district with 134,506 voters also elects only five District Judges.

The minority district is severely over-represented. Minority voters living near the minority subdistrict but in the Northern sub-district, give minority voters in the Northern

many natives of Africa, Dele is very conservative on social issues. He is strongly pro-life and pro-traditional marriage



# **Runoff Likely for 1st Circuit Court of Appeal**

**BATON ROUGE** — One of the most important races on the ballot for Tuesday, Nov. 8 is for the First Circuit Court of Appeal. This appellate court is the first line of defense against the bad decisions coming from the District Court in Baton Rouge, and there are many!

In years past, the district judges serving on the 19th Judicial District Court had a reputation for judicial restraint and respect for the Louisiana Constitution and the federal Constitution. However, with the creation of judicial sub-districts, liberal judges have become a majority on the court.

The sub-districts have not been reapportioned in 30 years. East Baton Rouge Parish is evenly split between black and white. As a result, the parish should have eight Democrats and seven Republicans on the District Court bench, or vice versa. Yet, because the sub-districts have not been reapportioned, Democrats now control the election of 10 of the 15 district judges in the parish.

Those Democrats are mostly liberal, and their decisions often need scrutiny. That's where the First Circuit Court of Appeal comes in. We have to count on them to correct the mistakes of the 19th Judicial District.

In the Nov. 8 election, two conservative Republicans – Judge Hunter Greene and Judge Beau Higginbotham - are on the ballot, as is Judge Don Johnson, a Democrat.

The Republican Party has co-

alesced around Judge Hunter Greene. Judge Greene who has been both a CPA and an attorney, served in the Louisiana House of Representatives for eight years and as Family Court judge for eight years. During his time in the Louisiana House, he had to vote on countless thousands of important bills that have charted the direction of our state. In that capacity, he proved himself to be a strong, outspoken leader and a solid conservative. As Family Court Judge, he has a reputation of being fair to the parties and careful to do justice in accordance with the state and

federal constitutions.

Judge Greene has won the endorsement of the Republican Party of East Baton Rouge Parish.

The other Republican candidate, Judge Beau Higginbotham is also a staunch conservative who is respected by the bar and who could be expected to do a fine job if elected. When asked why they chose Greene over Higginbotham, most members of the Republican Parish Executive Committee said that while both candidates are well qualified, Greene has a stronger campaign and is better positioned to win in the runoff.

A runoff is likely with Judge Don Johnson likely to face one of the Republicans. Judge Johnson is a fine person who works well with lawyers appearing in his court. However, he is a liberal Democrat. He received national attention recently when after the Supreme Court reversed Roe v. Wade, he refused to allow Louisiana's strong pro-life legislation to go into effect.

# **Central's Race for Mayor Hot and Heavy**

#### Barrow, Evans Offer Two Visions: Natural Growth vs. Utilize Taxes Better

**CENTRAL** — With city elections this Tuesday, Nov. 8, both Central Mayor David Barrow and challenger Mayor Pro-Tem Wade Evans are hard at work trying to persuade voters to swing their way.

Mayor David Barrow said he is running to complete the work he has begun. "Over the last three and a half years, we have made progress on many fronts. Roads, drainage, and other projects are now ready to become reality."

"This term has been devoted to planning. The next four years will be about putting those plans into reality. Roads and drainage are basic to our plans but there are many other things too."

"In a city, it's important that people be happy. That's why we do things like work with BREC to improve our parks and recreation."

"When I go around Central, people tell me they are happy with how things are going in the city. They want a rural, bedroom community. They want natural growth. That's why we've slowed things down a bit. By slowing down, we can afford to do the things people want done."

"When I was elected, I promised I would be transparent. I use

Facebook to inform people of what is going on, and they appreciate that. People like to be involved in what is happening but they have to be informed in order to do that."

"People like Central the way it is. I've tried to listen and have natural growth. Growth comes with time. You have to slow it down to a manageable level. We have 30,000 people in Central. You can't please everyone because not everyone thinks the same. But most people in Central are happy."

"The first four years, we worked on a lot of projects. We've started on some and have a lot more planned."

His opponent, Mayor Pro-Tem Wade Evans, has a very different take on where Central stands right now. He said,

"I'm tired of living in a city that doesn't get things done. We have so much potential but we're not fulfilling it."

"As a city government, we need to be that shining city on a hill. We need to be an example for other cities in Louisiana and that begins with putting God first in everything we do. I'm a lot different person than I was four years ago, because of my commitment to Christ."

"We are one of the highest taxed cities in our state -10.45% – but we are not utilizing those funds to meet the basic needs of our community, which is roads and drainage."


"Time and again, I have brought plans to the Mayor for us to be good stewards for the taxes we have collected, but I am rebuffed over and over again."


"For example, I brought forward a proposal to have a company do 20 acres of drainage for the city with a focus on roadside work. The Mayor rejected it."

"I brought forward a proposal for us to utilize Thermoplastics, a modern way to permanently repair pot holes. We only needed to invest \$10,000 for a test of the technology. The Mayor rejected it."

"As far as roads are concerned, Central doesn't have a plan. We have a traffic plan but that is sitting on a shelf. The Mayor refuses to put together a road improvement plan. I will put together a plan. It starts with making an inventory of our roads, assessing their condition, understanding what they need, and then developing a plan. We have to get something going. Do we want four more years of getting nothing done?"

"I want us to do more than clean out ditches. Cleaning out ditches is essential but we need to go far beyond that. There are bigger things we can do for this community."

# First Amendment Rights Have Key Role In Election for Chief of Police in Central

#### Will Voters Forget Dark Days of Covid Or Demand a New Face in Leadership

**CENTRAL** — Central voters will face a rematch from 2018 between the current police chief, Roger Corcoran, and the previous police chief, James Salsbury. Corcoran received nationwide criticism after arresting Pastor Tony Spell for holding worship services at Life

Tabernacle during the pandemic. In a statement, Corcoran said, "After taking office in January 2019, we have upgraded all antiquated equipment within the police department, including computers, software, a secured technology system, weapons for our officers, a secure reporting system for complaints, installation of an evidence tracking system and purchased the most up to date safety equipment for all of our officers. From day one, I have put my over three decades of law enforcement experience to work for you. We eliminated waste, improved our processes and made

our officers, and city, safer. Former Chief James Salsbury sees the current Police Department in Central in a very different light. Chief Salsbury said, "We need

to get our police department back

tremendously increased the cost of the police department while actually providing less service. "The department's budget has skyrocketed, but citizens are not getting their money's worth."

"You notice a large number of police units setting at the police station day and night. There are a couple of reasons for that.

First, the chief has a high turnover rate. So he can't keep good people. Second, he is not patrol-

on track." He said Corcoran has ling neighborhoods. Third, he is attempting to take over the role of the Sheriff's office in investigating crimes. Fourth, he is not handling traffic properly. Fifth, he is not providing assistance during carpool time at our schools.

The current chief has dramatically changed the type of service the department is providing and not for the better.'

"How will we make things better? First, we will treat people better and retain good officers.

"Second, we will patrol the neighborhoods. People want to see our units in their areas. A police presence in the neighborhood is the

best deterrent to crime." "Third, in regard to crime, our job is to get to the scene, hopefully while the crime is in progress. But the Sheriff's office is the proper agency to investigate the crime. A small department like Central sim-ply doesn't have the manpower and the expertise to investigate serious crime. The Sheriff's investigative unit will take over investigations once again.'


"Fourth, we will bring back our Traffic Division and properly patrol our roads and highways."

"Fifth, we will resume our service to Central schools. We will once again show up at carpool time to expedite the flow of traffic. The carpool should take 20 minutes, not an hour or two. We did it before, and we will again."

"As your police chief, I had a 10-year plan to build up our police department properly. We were in Year 4 of that plan when the new chief took over. We will get back on that 10-year track."

"Remember this: A police department must grow at the same rate as the city, not faster and not slower. If it grows too fast, the city can't afford it. If it grows to slow, essential services will be neglected and crime will skyrocket."

"Don't worry. As your chief, I will get us back on track!'


School Board District 6 - Michael Hooper was unopposed.
